MINOR CHILD RELEASE AND WAIVER OF LIABILITY

I, _____ (full name of Parent or Legal Guardian of Child) (hereafter "Guardian") am the parent or legal guardian having custody of _____ (full name of minor child), a minor child (hereafter "Child"). I hereby entered into this Release and Waiver of Liability (hereafter "Agreement") on behalf of myself individually and on behalf of the Child.

In consideration of Child being allowed to participate in activities and programs at New Vision Baptist Church, including, but not limited to, traveling to and from, and attending, engaging in activities and participating in activities at and/or with New Vision Baptist Church, Guardian, on behalf of his/herself and Child, his/her heirs, assigns, next of kin, and personal representatives, does hereby agree to release and forever discharge and hold harmless New Vision Baptist Church, its ministers, employees, leaders, agents, volunteers and independent contractors (hereafter "Releasees") from any and all liability, claims, demands, and causes of action of whatever kind or nature, including but not limited to negligence, breach of any duty of care or any claim whatsoever for personal injury, property damages, payment for medical treatment, illness, death, or accident sustained by the Child or any other person, whether or not resulting from the negligence or intentional actions of Releasees or any other individual, which may arise out of Child's participation in any activities or programs at New Vision Baptist Church. The Guardian and Child further hereby release and discharge Releasees from any and all claims which may arise on account of any first aid, treatment, medical treatment, or other emergency service rendered in connection with Child's participation in activities and programs at New Vision Baptist Church.

I do hereby grant permission to Releasees to use any and all photographic images and/or video/audio recordings made during Child's participation in activities and programs at New Vision Baptist Church for any purpose.

I further grant permission for Child to travel to and from, attend, engage in activities and participate in activities at and/or with New Vision Baptist Church.

This Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and this Agreement shall be governed by the laws of the State of Tennessee. Rutherford County, Tennessee is the proper venue for any action brought regarding the subject matter of this Agreement. In the event any provision of this Agreement shall be held to be invalid, the invalidity of such provision shall not otherwise affect the remaining provisions of this Agreement, which shall continue to be enforceable. I attest that I am over 18 years of age and I represent that I have full legal authority to execute this agreement on behalf of myself and the Child.
